Announcement of a recommended offer for Rotork

On 16 July 2026, Rotork and ABB Ltd (“**ABB**”) announced that they had reached agreement on the terms and conditions of a recommended offer to be made by ABB (through Bidco (as defined in the Announcement)) for the entire issued, and to be issued, ordinary share capital of the Company (the “**Acquisition**”).

The Acquisition relates to the ordinary share capital of the Company only. The Company and ABB (through Bidco) intend to make a separate proposal to the holders of preference shares in the Company (the “**Rotork Preference Shares**”), in respect of the acquisition by ABB (through Bidco) of all of the issued Rotork Preference Shares, which is intended to be implemented by way of the Preference Share Scheme (as defined in the Announcement).

In accordance with Rule 2.11 of the Code (the rules which govern a transaction of this nature), a copy of the announcement made pursuant to Rule 2.7 of the Code in connection with the Acquisition (the “**Announcement**”) has been made available on Rotork’s website at www.rotork.com/en/investors. A copy of the Announcement, this notification and all other information, documents and announcements relating to the Acquisition will be available on Rotork’s website at www.rotork.com/en/investors. This notification is not to be taken as a summary of the information in the Announcement and should not be regarded as a substitute for reading the Announcement in full. For the avoidance of doubt, the content of Rotork’s website is not incorporated into, and does not form part of, this notification.

It is expected that the Acquisition will be implemented by way of a scheme of arrangement under Part 26 of the Companies Act 2006. Any associated documentation will be sent to Rotork shareholders in due course, subject to any restrictions on distribution described in the Announcement.

Please be aware that addresses, electronic addresses and certain other information provided by you for the receipt of communications from Rotork may be provided to ABB during the offer period as required under Section 4 of Appendix 4 of the Code.

Disclosure requirements of the Code

Under Rule 8.3(a) of the Code, any person who is interested in 1% or more of any class of relevant securities of an offeree company or of any securities exchange offeror (being any offeror other than an offeror in respect of which it has been announced that its offer is, or is likely to be, solely in cash) must make an Opening Position Disclosure following the commencement of the offer period and, if later, following the announcement in which any securities exchange offeror is first identified.

An Opening Position Disclosure must contain details of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s). An Opening Position Disclosure by a person to whom Rule 8.3(a) applies must be made by no later than 3.30 p.m. (London time) on the 10th business day following the commencement of the offer period and, if appropriate, by no later than 3.30 p.m. (London time) on the tenth business day following the announcement in which any securities exchange offeror is first identified. Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure.

Under Rule 8.3(b) of the Code, any person who is, or becomes, interested in 1% or more of any class of relevant securities of the offeree company or of any securities exchange offeror must make a Dealing Disclosure if the person deals in any relevant securities of the offeree company or of any securities exchange offeror. A Dealing Disclosure must contain details of the dealing concerned and of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror, save to the extent that these details have previously been disclosed under Rule 8. A Dealing Disclosure by a person to whom Rule 8.3(b) applies must be made by no later than 3.30 p.m. (London time) on the business day following the date of the relevant dealing.

If two or more persons act together pursuant to an agreement or understanding, whether formal or informal, to acquire or control an interest in relevant securities of an offeree company or a securities exchange offeror, they will be deemed to be a single person for the purpose of Rule 8.3.

Opening Position Disclosures must also be made by the offeree company and by any offeror and Dealing Disclosures must also be made by the offeree company, by any offeror and by any persons acting in concert with any of them (see Rules 8.1, 8.2 and 8.4).
